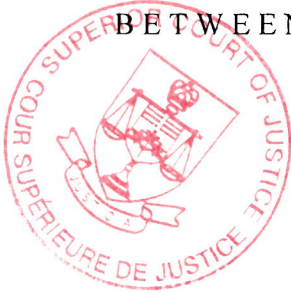

ORDER – FUNDING APPROVAL

THIS MOTION, made by the Plaintiffs for an Order awarding Claims Funding International, Plc. (“CFI”) a preliminary commission payment of \$1,711,540.09 and an order releasing for cancellation all of CFI’s letters of credit currently being held by the Accountant of the Superior Court of Justice (the “Accountant”) was heard this day, at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.

ON READING the materials filed and on hearing the submissions of Counsel for the Plaintiffs;

1. **THIS COURT ORDERS** that the Administrator pay, from the Manulife settlement fund, a preliminary commission to CFI of \$1,711,540.09.




2. **THIS COURT ORDERS** that the Accountant of the Superior of Justice release for cancellation all letters of credit it is holding in this matter, Court File No. CV-09-383998-00CP, and specifically the letters of credit pertaining to Account Number 519118, including letters bearing the Description:

- (a) BMTO339353OS, dated July 28, 2011;
- (b) BMTO433841OS, dated March 16, 2015;
- (c) BMTO505621OS, dated July 19, 2016; and
- (d) BMTO488015OS, dated December 22, 2015.

3. **THIS COURT ORDERS** that in the event that the preliminary commission awarded in this order exceeds the commission due to CFI, after the total number of claimants to the Manulife settlement fund is known, CFI will return to GCG any excess commission with 14 days of the final number of claimants being determined.


